The National Government has awarded two CPA firms to conduct the single audits for the five (5) Primary Governments and their component units. The two CPA firms are Ernst & Young LLP (EY) and Burger Comer Magliari CPAs (BCM). EY is awarded the audits for National, Chuuk, and Kosrae State Governments and their component units while BCM is awarded the audits for Pohnpei and Yap State Governments and their component units.

This is the first monthly status report for the FY2022 single audits, and it is as of May 31, 2023. This report is based on information received from our contracted auditors.
